TOURIST MEDICAL SERVICE

In the event of a life-threatening emergency or a serious health condition, emergency medical services should be contacted immediately by calling 194 or 112.

In the event that the above-mentioned medical practices are unavailable, tourists staying in the Šibenik-Knin County area during the tourist season who require healthcare services may access them as follows:

Citizens of the European Union who are visiting Croatia or are staying temporarily for other reasons, and who are insured in an EU Member State, are entitled to use the European Health Insurance Card (EHIC) to access healthcare services, subject to the applicable co-payment, at any medical practice in the county or at the designated on-duty medical practice located at Zvonimirova 23, Šibenik.

The costs of medical services provided to persons from countries with which Croatia has not concluded bilateral agreements are charged directly to the patient in accordance with the applicable price list. Tourists may also use the services of private doctors and dentists, in which case the full cost of services have to be paid by the patient.
